#### 1. Executive Summary:

Major outcomes, results and impact of the Chair, including on national policies, in relation to its objectives as stated in Article 2 of the Chair Agreement (between the Institution and UNESCO) (Not exceeding 300 words)

This is the eighth full year as UNESCO chargé de mission. The original contract as chargé de mission to the ADG Culture was signed in August 2011, renewed in January 2012 and January 2013, and subsequently renewed as chargé de mission to the Director of the World Heritage Centre in January 2014, and since January 2015 further renewed annually as chargé de mission to the Director for Heritage, Dr Mechtild Rossler. The 2020 contract was signed in March by the D-G. In accordance with the contract, the main activities proposed during the year 2020 were:

- a. Provide advice and make recommendations regarding initiatives and actions that the World Heritage Centre may undertake in the field of World Heritage conservation, especially regarding the safeguarding of cities and urban landscapes;
- b. Contribute to the World Heritage Cities Programme and the preparation of guidance materials and tools for a Resource Manual on the Historic Urban Landscape as well as relevant changes to the Operational Guidelines;
- e. Advise on issues related to sites of memory (Auschwitz Birkenau German Nazi Concentration and Extermination Camp (1940-1945) and provide inputs on initiative on heritage of religious interest (including for the thematic paper);
- d. At the specific request of the Director of the World Heritage Centre, carry out relevant expert missions or represent UNESCO and the World Heritage Centre at events and provide any other advice as required.

Many of the activities are intertwined, and coordination has been with the Director and staff of the World Heritage Centre through skype and information meetings. The activities of the chargé de mission have been supported by the UNESCOChair at the Bezalel Academy and below are those activities attributed to the contract and that were performed during the year. The report follows the format of previous years.

# 2) Activities:

Overview of activities undertaken by the Chair during the reporting period

# a) Education/Training/Research

(key education programmes and training delivered and research undertaken by the Chair during the reporting period, target group and geographical coverage)

i) Education (leading to certificate)	The Graduate Program in Urban Design at the Bezalel Academy was recognised as a UNHabitat University in September 2017. A specific course in Urban Innovation was given in furthering the Recommendation on the Historic Urban Landscape and the Action Framework for the Implementation of the New Urban Agenda – AFI-NUA.
ii) Training (short term)	The UNESCO Chair participates in EU research projects and supports national programmes for conservation including the Historic Urban Landscape Recommendation and the UNDRR Resilient Cities programme.  Lectures and seminars for conservation training and capacity building
iii) Research	First full year of HERILAND, a pan-European research and training network on cultural heritage in relation to Spatial Planning and Design with six universities and 15 PhD candidates. It is funded by the European Union's Horizon 2020 research and innovation programme under the Marie Sklodowska-Curie grant agreement No 813883.  Preparation of two EU actions that will commence in the coming months:  EDICULA is an innovative approach that fuses the interdisciplinary collaboration among the sectors of applied sciences in the protection of monuments with humanities disciplines using XR technologies, to develop an educational framework to advance scientific transdisciplinary synthesis. This is an ERASMUS activity together with La Sapienza, Rome and NUTA, Athens for generating a joint master's programme on conservation and PhD curricula. It commenced in September 2020 and will include conservation works and interpretation of the Aedicule, the Tomb of Jesus and the urban context of the Holy Sepulchre.

CONSIDER aims to develop sustainable management model (SMM) for industrial heritage sites (IHS) for the benefits of the local communities as a resource for strengthening collective identities, improving the urban landscape, promoting eco-friendly solutions, and contributing to the urban economy and a sustainable future of the city. This is of an EU Marie Curie RISE programme with 12 partners – six academic institutions and six 'end-users' and due the COVID-19 the commencement is postponed till April 2021.

The EU funded projects, specific research grants and contracts and for which the Chair is associated, are integrated within the Department; as were the support given by other agencies.
